PART A – Description of the ILUA Area

Ewamian People & Etheridge Shire Council - Charleston Dam ILUA

External boundary description

The agreement area covers all the land and waters within the external boundary described as:

- Lot 19 on AP21258
- Lot 20 on AP21258
- Lot 22 on AP22315
- Lot 60 on C4522
- That part of Lot 5306 on SP201262 (Rose Glen Holding) south of the line:

Commencing at the intersection of the northern bank of the Delaney River and Longitude 143.574324° East and extending generally easterly passing through the following coordinate points:

Longitude° East	Latitude° South
143.583314	18.543057
143.584852	18.544168
143.584553	18.545364
143.587842	18.550619
143.593311	18.549893
143.604761	18.549936

Then southerly to the northern bank of Finnegan Creek at Longitude 143.604837° East.

- That part of Lot 9 on GB82 northwest of the line:

Commencing at a point on the eastern boundary of Lot 9 on GB82 at Latitude 18.553970° South and extending generally westerly passing through the following coordinate points:

Longitude° East	Latitude° South
143.598395	18.555490
143.598224	18.556857
143.596601	18.557113
143.595063	18.556131
143.590107	18.557028

Then southerly to the southern boundary of Lot 9 on GB82 at Longitude 143.590021° East.

- That part of Lot 14 on GB105 west of the line:

Commencing at a point on the southern boundary of Lot 9 on GB82 at Longitude 143.593878° East and extending generally southerly passing through the following coordinate points:

Longitude° East	Latitude° South

Then southerly to the southern boundary of Lot 14 on GB105 at Longitude 143.597604° East.

And that part northwest of the line:

Commencing at a point on the southern bank of Finnegan Creek at Longitude 143.604837° East and extending southerly and south westerly through Longitude 143.604847° East, Latitude 18.552798° South to the eastern boundary of Lot 9 on GB82 at Latitude 18.553970° South.

- That part of Finnegan Creek west of Longitude 143.604837° East.
- That part of the Delaney River southeast of the prolongation of the western boundary of Lot 22 on AP22315 and northwest of the prolongation of the southern boundary of that lot.

Reference datum

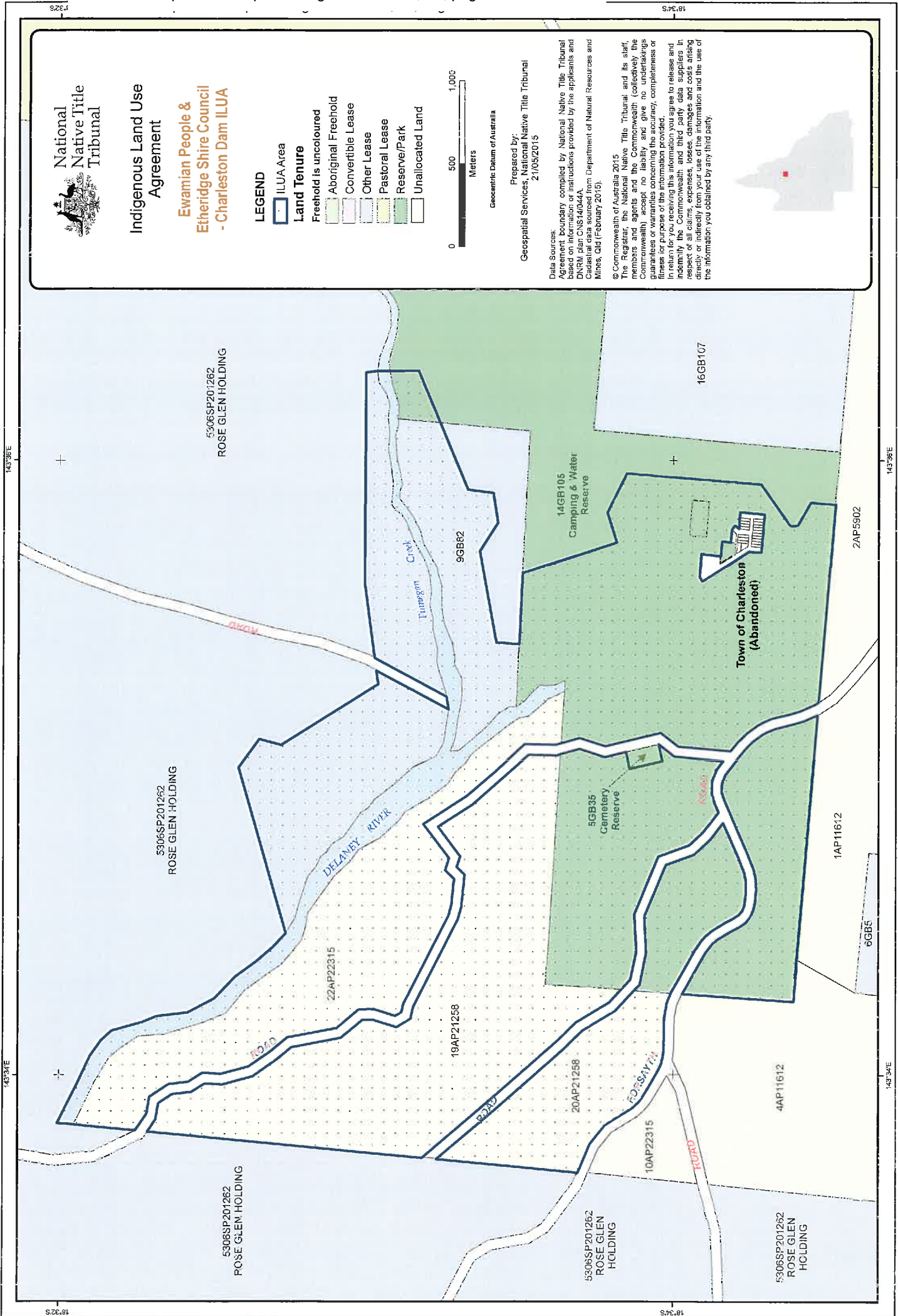

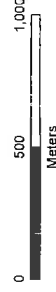
PART B – Plan of ILUA Area
