SCHEDULE 5 – Examples

This schedule lists some examples only of acts which constitute or may constitute Project Activities and which are included the class contained in clause 9.1.

- 1. Grant, variation, extension, renewal or re-grant of a lease.
- 2. Grant, variation, extension, renewal or re-grant of an easement.
- 3. Grant, variation, extension, renewal or re-grant of a permit to occupy.
- 4. Grant, variation, extension, renewal or re-grant of an authority to prospect.
- 5. Grant, variation, extension, renewal or re-grant of a data acquisition authority.
- 6. Grant, variation, extension, renewal or re-grant of a water monitoring authority.
- 7. Grant, variation, extension, renewal or re-grant of a petroleum lease.
- 8. Grant, variation, extension, renewal or re-grant of a pipeline licence.
- 9. Grant, variation, extension, renewal or re-grant of a petroleum facility licence.
- 10. Grant, variation, extension, renewal or re-grant of a survey licence.
- 11. Grant, variation, extension, renewal or re-grant of a water licence.
- 12. Grant, variation, extension, renewal or re-grant of a dam licence.
- Grant, variation, extension, renewal or re-grant of any tenement, interest in land, authorisation, approval, permission, consent, certificate or direction from any government, department or decision maker under the Petroleum and Gas Act.
- 14. Dedication of, and change to, a reserve.
- 15. Dedication, opening of and changes to a road.
- 16. Giving of, or changes to, any statutory or regulatory approval, permission or consent and any approval, permission or consent by any decision maker under any Law.
- 17. Any act which consists of geotechnical investigations, site preparation, clearing, pegging, surveys and other planning and preparatory acts.
- 18. Any act which consists of the construction, operation, use, maintenance or repair of any gas wells and reinjection wells.
- 19. Any act which consists of the construction, operation, use, maintenance or repair of any gas wellhead facilities.
- 20. Any act which consists of the construction, operation, use, maintenance or repair of any gas and water gathering systems and pipelines.
- 21. Any act which consists of the construction, operation, use, maintenance or repair of any gas field compression facilities.
- 22. Any act which consists of the construction, operation, use, maintenance or repair of any central gas processing facilities or integrated gas processing facilities.
- 23. Any act which consists of the construction, operation, use, maintenance or repair of any water bores, water monitoring bores, dams, water transfer stations, ponds, water storages, water treatment facilities, water distribution or water transmission facilities or water irrigation facilities.

- 24. Any act which consists of the construction, operation, use, maintenance or repair of any powerlines, power generators and power stations.
- 25. Any act which consists of the construction, operation, use maintenance or repair of any workers accommodation facilities.
- 26. Any act which consists of the construction, operation, use maintenance or repair of any lay down and storage areas and facilities.
- 27. Any act which consists of the construction, operation, use maintenance or repair of any roads and access tracks including road and track widenings and upgrades.
- 28. Any act which consists of the construction, operation, use maintenance or repair of any midline gas compression units and gas field or gas pipeline control facilities.
- 29. Any act which consists of the construction, operation, use, maintenance, or repair of any telecommunication facilities, weather stations, workshops, warehouses, offices, site remediation and waste disposal facilities.
- 30. The grant of permission to the area of any pipeline licence or petroleum facility licence to construct and operate a pipeline or petroleum facility for the purposes of sections 401(2) and 441(2) of the Petroleum and Gas Act.
