Description of the area covered by the agreement

The agreement area is described in 3.11 and means all the land and waters subject to Pastoral Lease Number 2491 recorded in Crown Lease Register Book Volume 1433 Folio 13 known as Ayers Range South (excluding any existing public roads) which falls within native title determination application SAD208/2010 Tjayiwara Unmuru Native Title Claim (SC2010/5) as accepted for registration on 5 October 2011 (see Third Schedule).

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The Agreement Area covers the Ayers Range South Pastoral Lease (about 1,288 sq km) located approximately 10 km north of Agnes Creek (De Rose Hill) Homestead.]
