### Description of the area covered by the agreement

Agreement Areas means the area of the Amban Access Track and the Access Upgrade Areas.

Amban Access Track means:

- (a) the track known as "the Amban access track" within Lot 211, and shown as "Amban Track" on the map in Schedule 1 [of the agreement]; and
- (b) the other tracks shown as "Access Tracks" on the map in Schedule 1 [of the agreement].

Access Upgrade Areas means the areas of Lot 211 which are or are proposed to be the subject of the Access Upgrade Works.

[A map of the agreement area is contained in Schedule 1 of the agreement and a copy is attached to this register extract.

The Agreement Area is located approximately 38 km northeast of Aurukun. The Area consists of a 27km long, generally 4 metre wide, corridor and covers approximately 0.11 sq km.]

2.5(c) For the purposes of section 24EB(1)(c) and regulation 6(5) of the ILUA Regs, if this document is registered on the Register [of Indigenous Land Use Agreements], Subdivision P of Division 3 of Part 2 of the Native Title Act is not intended to apply to any grants, consents or permissions provided to RTAW [RTA Weipa Pty Ltd] or its Personnel under this document.

3.4(b) NAK gives the Approvals Consent and any further consents necessary to give effect to the Approvals Consent and the parties agree that, for the purposes of section 24EB(1) of the Native Title Act, such consents are the parties' consent.

## Definitions

Approvals Consent means the consent to the grant of all Approvals required or desired by the RTAW for the Track Activities.

Track activities means the use of the Agreement Areas by RTAW and its Personnel as contemplated by this document [the agreement] including for:

- (a) the activities permitted under clause 3.1 [road up grade activities and on-going maintenance activities];
- (b) the conduct of the Access Upgrade works;
- (c) the Upgrade Access;
- (d) activities reasonably incidental to the activities referred to in paragraphs (a) to (c) of this definition.

Agreement Areas means the area of the Amban Access Track and the Access Upgrade Areas.

Amban Access Track means:

- (a) the track known as "the Amban access track" within Lot 211, and shown as "Amban Track" on the map in Schedule 1 [of the agreement]; and
- (b) the other tracks shown as "Access Tracks" on the map in Schedule 1.

Access Upgrade Areas means the areas of Lot 211 which are or are proposed to be the

subject of the Access Upgrade Works.

Access Upgrade Works means the works proposed or described in Figures 3-1 to 3-16 and 3-19 in the draft development application in Schedule 2 [of the agreement].
