

SCHEDULE 1 – WRITTEN DESCRIPTION

This schedule details the written description of the ILUA Area.

The ILUA Area covers all land and waters within the external boundary described below.

A map depicting the ILUA Area is contained in Schedule 2.

External Boundary

Commencing at a point at Latitude -26.063099 Longitude 150.282442 also being the intersection of Native Title Determination Application QUD6162/98 Iman People #2 and Native Title Determination Applications QUD311/11 Wulli Wulli People #2 and QUD621/11 Wakka Wakka People #3; then generally easterly, generally southerly, generally south westerly, again generally southerly and again generally easterly along the boundaries of Native Title Determination Applications QUD311/11 Wulli Wulli People #2 and QUD621/11 Wakka Wakka People #3 to a point at Latitude -26.183137 Longitude 150.334423; then generally south easterly and generally south westerly through the following coordinates:

Then east to a point at Latitude -28.081757 Longitude 151.047755 also being the intersection of Native Title Determination Application QUD101/09 Bigambul People; then generally northerly, generally westerly and generally south westerly along that Native Title Determination Application to a point at Latitude -27.570935 Longitude 150.234960 also being a point on the boundary of Native Title Determination Application QUD366/08 Mandandanji People; then generally northerly along that Native Title Determination Application to a point at Latitude -27.325190 Longitude 150.167756; then north, east, again north; and generally north westerly through the following coordinates:

Then north to Latitude -26.221057 Longitude 149.951006 also being a point on the boundary of Native Title Determination Application QUD6162/98 Iman People #2; then north easterly along that Native Title Determination Application back to the commencement point.

Reference to Native Title Determination Application QUD311/11 Wulli Wulli People #2, QUD621/11 Wakka Wakka People #3, QUD101/09 Bigambul People, QUD366/08 Mandandanji People & QUD6162/98 Iman People #2 in this schedule relate to their boundaries as they existed as at 15 October 2012.

Latitudes and Longitudes referenced in the boundary description above are referenced to GDA94.
