- 2.2 Clauses 4 (Agreement Binding), 5 (Consent to and Validating of Agreed Acts), 9 (Compensation) and 10 (Release, Waiver and Indemnity) commence on the Registration Date.

## Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

- 5. Consent to and Validating of Agreed Acts
- 5.1 The parties:
- (a) consent to the doing of the Agreed Acts to the extent that they are Future Acts; and
- (b) if any of the Agreed Acts done prior to the Registration Date are invalid Future Acts, agree to the validating of those Agreed Acts.
- 5.2 Clause 5.1(a) is a statement for the purposes of section 24EB(1)(b) of the NTA and clause 5.1(b) is a statement for the purposes of section 24EBA(1)(a) of the NTA.
- 6. Right to Negotiate

To avoid any doubt, Part 2 Division 3 Subdivision P of the NTA does not apply to the doing of the Agreed Acts.

#### 1. Interpretation

- "Agreed Acts" means all acts necessary to give effect to this Agreement, the IMAs and the Conservation Agreements, including:
- (a) the grant of the Proposed Northern ALA Area as Aboriginal Land to the Northern Corporation under the ALA;
- (b) the grant of the Proposed Southern ALA Area as Aboriginal Land to the Southern Corporation under the ALA;
- (c) the grant of the Proposed Kalpowar ALA Area as Aboriginal Land to the Kalpowar Aboriginal Land Trust;
- (d) the State and the Northern Corporation entering into, being bound by and complying with the Northern IMA:
- (e) the State and the Southern Corporation entering into, being bound by and complying with the Southern IMA;
- (f) any variation of the Southern IMA and the Northern IMA;
- (g) the dedication, use and management of the Proposed National Park (CYPAL) Areas as national park (Cape York Peninsula Aboriginal land);
- (h) use and management of the Kalpowar Nature Refuge in accordance with the Kalpowar Conservation Agreement under the NCA;

- (i) use and management of the Melsonby (Gaarraay) Nature Refuge in accordance with the Melsonby (Gaarraay) Conservation Agreement and the NCA;
- (j) dedication of the Proposed Road Area as Road; and
- (k) Relevant Acts.
- "ALA" means the Aboriginal Land Act 1991 (Qld).
- "NCA" means the Nature Conservation Act 1992 (Qld).
- "Northern Corporation" means Cape Melville, Flinders & Howick Islands Aboriginal Corporation ICN 7847
- "Southern Corporation" means the Buubu Gujin Aboriginal Corporation ICN 7852.
